#### 3. Research Merits

#### 3.1 Research profile

My research field is, in broad terms, legislation that governs *property rights and land use* topics. This extensive domain can be divided into four more distinct categories: 1) Different *property rights* systems, 2) legal rules for provision, operation and financing of *infrastructure*, 3) *procedural aspects* of public decision-making, and 4) the *historical development* of these aspects.

The definition and efficiency of *different property rights systems* - ownership, tenancy, lease, easement, joint property rights, mineral rights etc. – is of fundamental importance to society's possibility to allocate resources. This research topic is of general interest since the design of property rights create different incentives and influence the costs of transactions. Some of the issues I have dealt with in this category include: What are the economic functions of ownership to land in a society? To what degree does ownership need to be defined regarding content (i.e. rights and responsibilities)? In what ways have the rights and responsibilities that constitute ownership in the Swedish system developed over time? In what ways does the content of Swedish ownership differ from ownership in similar countries, are there possibilities for improvements?

In order to be functional, individual property units normally need supplementary infrastructure, e.g. roads, green areas, electricity, water supply, different kinds of telecommunications etc. There are different legal possibilities for *provision, operation and financing of these types of infrastructure*. An important dividing line can be drawn between individual and collective solutions. When it comes to collective alternatives, the joint action can furthermore be organized as a private, communal or state responsibility. Some of the issues I have studied in this category include: Who should be responsible for different types of infrastructure? Which criteria should be critical for the optimal choice of principal responsibility? When it comes to private responsibility, in what situations are individual or collective solutions optimal? How should financing of infrastructure be organized, fees or taxes? And how should the fees or taxes be distributed?

The third area concerns *procedural designs* of public decision-making in the context of land use permissions, land acquisitions and compensation issues. What are the procedural characteristics? To what extent can the parties influence the final allocation? Is consent necessary or may compulsion be used? These questions all have strong bearing on issues such as efficiency and legitimacy. Within this category I have, inter alia, worked with the following topics: What land uses need public regulations, e.g. as requirements for permissions or planning? How has public regulations of different land uses developed over time, and what were the historical reasons for the reforms? How should decision-making procedures be designed, in order to achieve efficient allocations and optimize on transaction costs? Why are different types of decisions resolved in different types of procedures, e.g. political, administrative or court procedures?

The fourth subcategory of my research concerns *historical developments*, which is an area I have studied to some extent for a long time. Lately I have devoted a more concentrated interest in this dimension. History is the foundation for the systems of today. Modern legal institutions generally contain large intact features that mirror former institutions. By knowing history, our understanding of the present systems is improved and enriched. Some of the issues I have studied in this subcategory include: Can historical institutions be understood as efficient solutions by analyzing them in the technical, economic and social context of their own time? Are the present institutions designed to solve society's needs and problems of today or of yesterday? What conclusions can be drawn from successes and failures during previous reforms and times?

Legislation on real property and land use is national. Due to this fact, most of my publications are written in Swedish. My ambition is to treat research topics both from a system perspective – e.g. to evaluate the system at a meta-level – as well as to penetrate certain legal details more in depth.

The research field of property rights and land use legislation is multi-disciplinary, i.e. it comprises law, economics, political science, technology etc. I have in particular used the recent achievements in the field of law and economics as a methodological foundation.

The conference took place at KTH Campus and had representatives and researchers from Denmark, Finland, Norway and Sweden. During the conference I also presented a paper, which was later accepted for publication. Another valuable outcome from this conference was the establishment of a partnership between the Nordic universities in the form of a Nordic PhD-school (joint courses, seminars, PhD research projects etc.).

### 4. Pedagogical Merits

#### 4.1 Teacher profile

My experiences as a teacher stretches back to 1992, when I started my own PhD-education and was introduced to teaching (as part of department duties at the Division of Real Estate Planning and Land Law). The subject area of my teaching mainly covers how legal rights associated with land use and real property can be established and/or modified in order to facilitate desirable societal development, e.g. construction of buildings with complementary infrastructure, or conservation and protection of valuable natural or historical areas.

As elaborated below, my teaching activities have over the years been quite extensive and diverse. I have been responsible and examiner for several courses at first, second and third cycle levels. At present I participate in more than 20 courses at KTH, as well as one course at Stockholm University and one course at Uppsala University. According to my "track record" for the last ten years I have on the average provided 150-200 hours of lectures, seminars and exercises (preparation and examination not included). To this, supervision of Bachelor's, Master's and Doctoral theses should be added, see below.

My general view of teaching and learning, is that learning should be seen as an active process by the students whereby new experiences are reflected upon, abstracted and actively tested to supplement or adjust previous knowledge structures. These underpinnings builds on Kolb's well known theory of experiential learning. Regarding the concept of different learning styles, I think it is important that the learning activities directed towards a specific learning objective should be various and multiple in order for all course participants to achieve optimal learning.
