Completed upper secondary education including documented proficiency in Swedish corresponding to Swedish B and English corresponding to English A. For students who received/will receive their final school grades after 31 december 2009, there are additional entry requirements as follows: Mathematics D, Physics B and Chemistry A.

# Language of instruction

The language of instruction is specified in the course offering information in the course catalogue.

#### Intended learning outcomes

After the course a student should be able to:

- Explain the function, financing and management of the real estate market.
- Describe the financial sector, the financial system and the role of the financial markets in the planning and building process in society.
- Explain how the legal system and laws affect different actors within the real estate sector and the financial system.
- Make capital investment appraisals and reflect upon how these are connected to public investment appraisals.
- Find and use different sources of information for the written assignment.
- Write a well-structured and informative essay and orally present the results.

#### **Course contents**

The course is an introduction to a number of important areas within real estate and finance; the role and function of the financial system, the real estate market, economics and capital investment appraisal.

The students will get practical experience of collecting and analyzing information in a scientific correct way in writing a written report.
